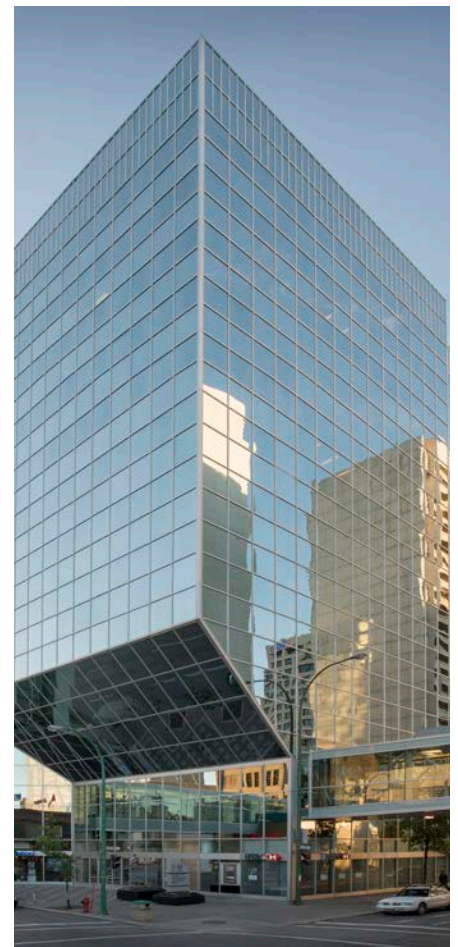
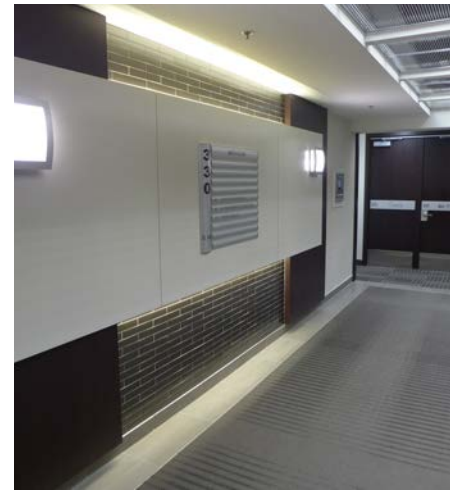

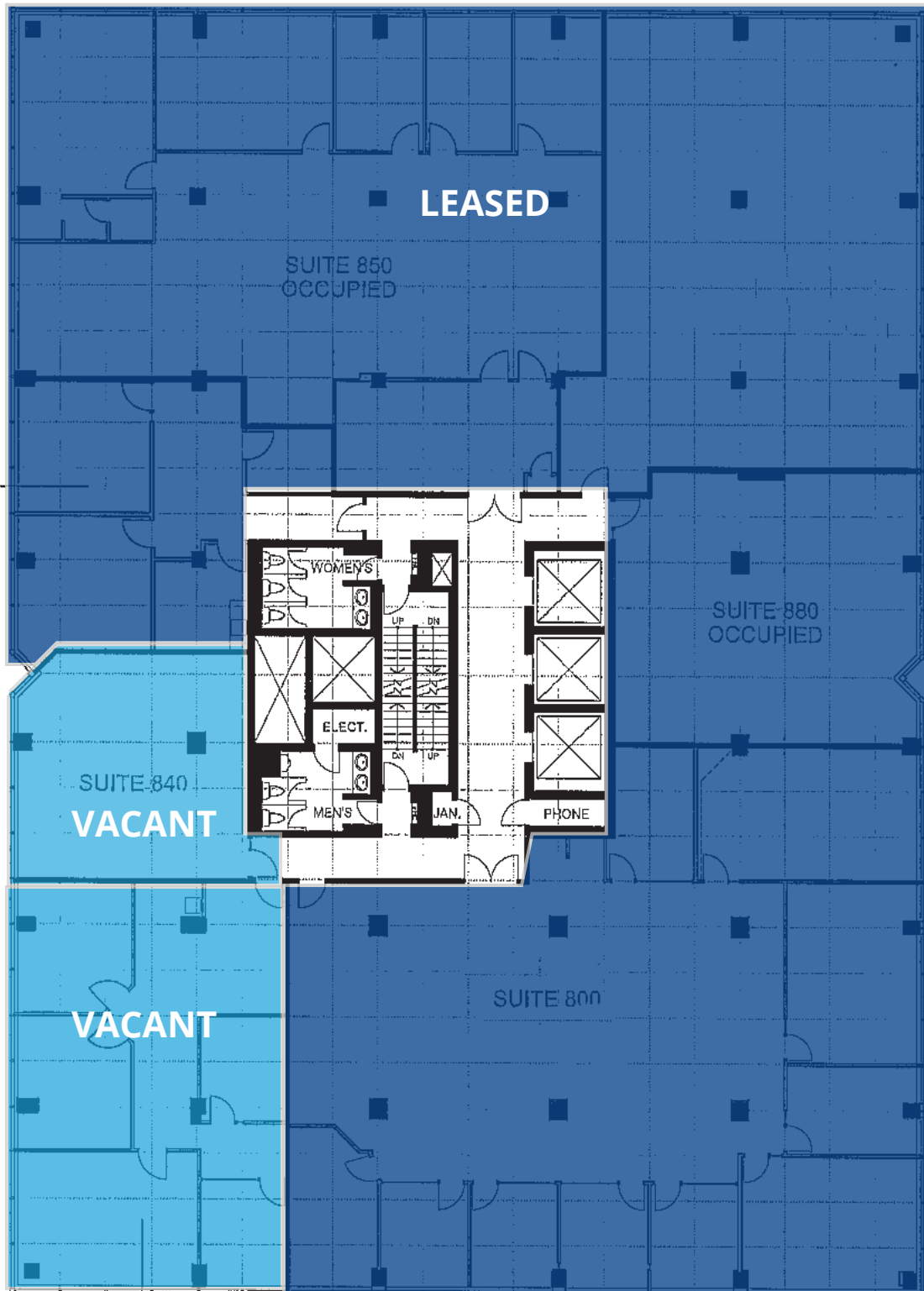

BOMA Best Silver is awarded to buildings that have met the BEST Practices and have achieved between 50 and 79% on the questionnaire.

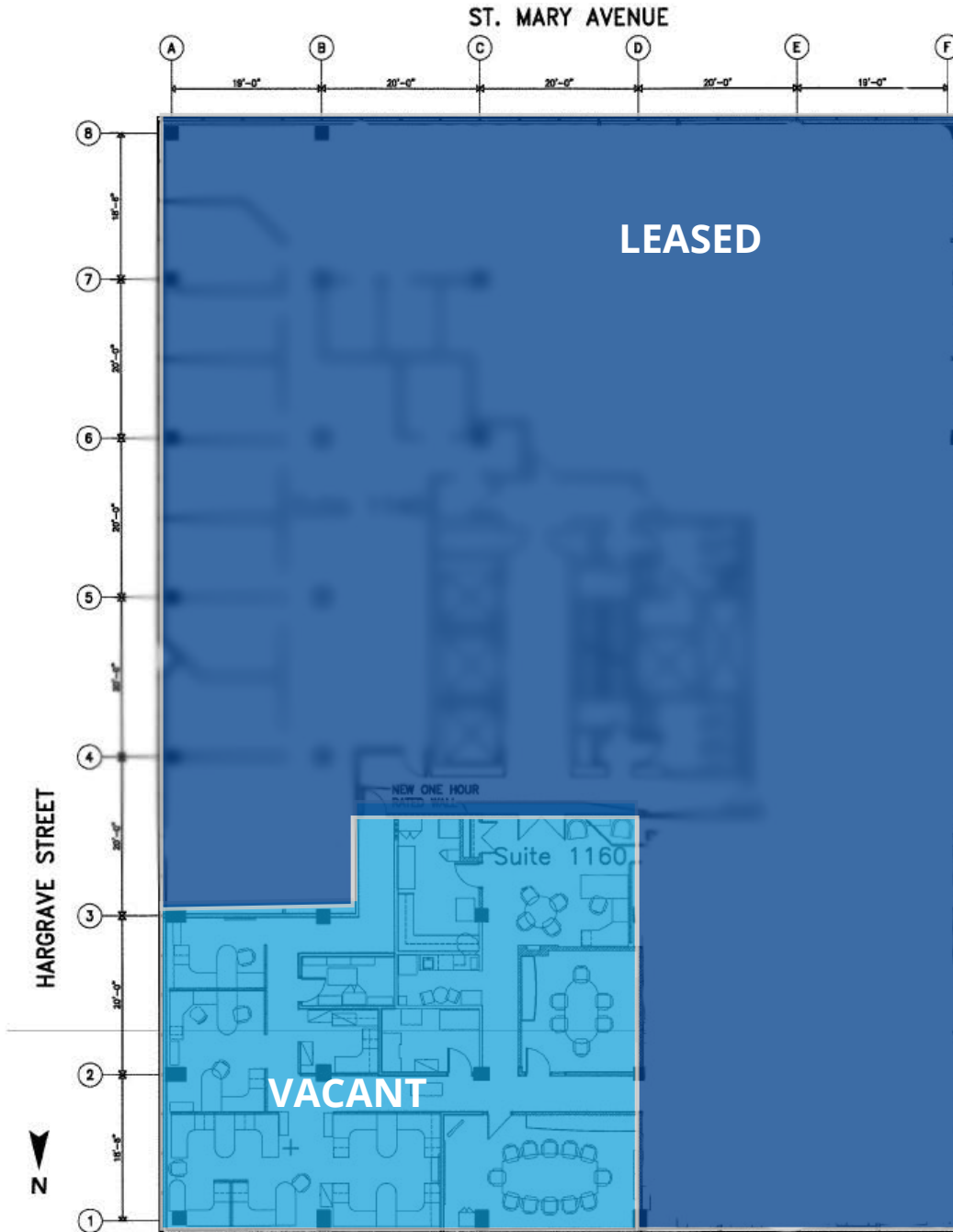
Floor Plans

8th Floor



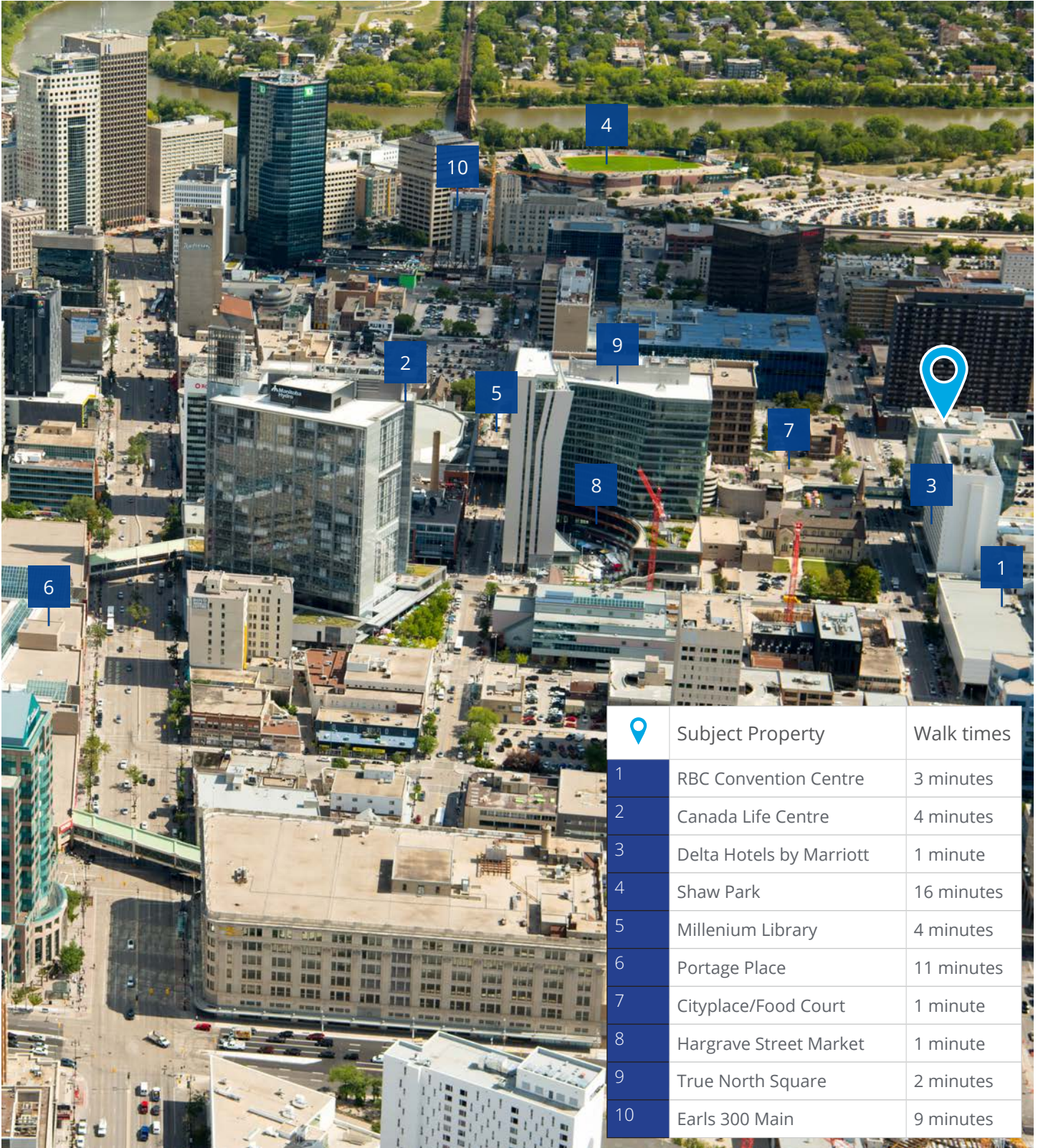
