200 Waterfront Drive is a high-quality, modern 4-storey 45,000 sf office building located on the corner of Waterfront Drive and Monte Nathanson Way (Lombard Ave).

Built in 2001, this landmark property was the first major step in redefining Waterfront Drive, blending modern architecture with the neighbourhood's vibrant and historic character.

The property benefits from its prime location being directly across from Blue Cross Park, home of the Winnipeg Goldeyes, and is surrounded by a growing base of multifamily residential developments along Waterfront Drive.

This built-in audience of sports fans, residents, professionals, and visitors creates a dynamic customer base ideal for professional offices and retail uses such as restaurants, cafés, and bar concepts.

Tenants will also enjoy being in close proximity to some of Winnipeg's top attractions, including The Forks, Canadian Museum for Human Rights, and Canada Life Centre, as well as the Exchange District's vibrant dining and brewery scene.

Available for lease is the main floor and mezzanine, providing up to 7,647 sf of contiguous space connected by an internal staircase with potential demising options available for smaller tenants. Although currently built out as an office with the last tenant being National Bank, the entire unit has previously been occupied for restaurant use with the added bonus of a patio area offering seating overlooking the Red River and Steven Juba Park.

This location offers the rare chance to anchor your business in a high-visibility, amenity-rich location within one of Winnipeg's most desirable and vibrant downtown corridors.


